A USAPA-SANCTIONED TOURNAMENT ALLOWS PLAYERS TO BE RANKED ON A NATIONAL BASIS BY RECEIVING TOURNAMENT POINTS FOR BEING MEDAL WINNERS IN APPROVED EVENTS. USAPA-SANCTIONED TOURNAMENTS ARE INSURED BY A GENERAL LIABILITY POLICY AND PARTICIPANT ACCIDENT POLICY. THE USAPA ORGANIZES AN ANNUAL NATIONAL TOURNAMENT FOR ALL AGE GROUPS.
