A USAPA-SANCTIONED TOURNAMENT ALLOWS PLAYERS TO BE RANKED ON A NATIONAL BASIS BY RECEIVING TOURNAMENT POINTS FOR BEING MEDAL WINNERS IN APPROVED EVENTS. USAPA-SANCTIONED TOURNAMENTS ARE INSURED BY A GENERAL LIABILITY POLICY AND PARTICIPANT ACCIDENT POLICY. THE USAPA ORGANIZES AN ANNUAL NATIONAL TOURNAMENT FOR ALL AGE GROUPS. REGIONAL, STATE AND LOCAL TOURNAMENTS ARE HELD THROUGHOUT THE YEAR AND ORGANIZED BY LOCAL CLUBS, ORGANIZATIONS AND INDIVIDUALS. IN 2017, THE USAPA SANCTIONED 104 TOURNAMENTS.
